Stanley A. Kubas

(October 25, 1920 - October 28, 2013)

Stanley Andrew Kubas, age 93, passed away Monday, October 28, 2013 after several months of failing health. Stan was born in Brooklyn, NY on October 25, 1920, son of the late Thomas and Aniela (Fedorowicz) Kubas who were Austrian/Polish immigrants to the U.S. in the early 1900's. His parents and his only sister all died within several months of one another in 1929 and 1930. It was then that his Aunt Mary Kramarz raised Stan and his two younger brothers in West Rutland, Vermont, where he attended 8 years of grammar school.



Stan was a member of the Civilian Conservation Corps from 1937 to 1939. The U.S. Forestry Service in Bradford, VT employed him from 1939 to 1940. He joined the U.S. Army in 1940, and in 1941 completed the Quartermaster Corps School for Bakers and Cooks at Camp Edwards, MA. He actively served as a mess sergeant where he supervised 52 men in the preparation of food for 4,000 men. He also performed duties in Casablanca, Africa during World War II. He received several decorations and citations: Good Conduct Medal, American Defense Service Medal, American Theater Service Medal, and European African Middle Eastern Service Medal. He was honorably discharged from the U.S. Army in November 1951.

He was married to Marion Butler on August 2, 1947 in Holy Angels Church in St. Albans. They raised their six children on Walnut Street in St. Albans. Stan enjoyed building and repairing things throughout his life. His carpentry skills shined when he designed and built his house on Walnut St. in the early 1950's. It was there that he spent much time tending to his vegetable garden. He and Marion spent many hours harvesting and canning produce to feed their family. He also raised chickens for the eggs and meat. Stan also enjoyed the outdoors by fishing and bird watching. He especially liked going on bus tours with friends. Stan was a strong-willed, hardworking man who taught his children a good work ethic. He used a common sense approach in dealing with situations, an approach that has served him well.

He was an active lifetime member in the local chapter of the

American Legion Post #1, and of the 40 & 8. He was also a charter member of the Veterans of Foreign Wars, Robert E. Glidden Post #758. He prepared many tasty meals for members and guests of both of these organizations. He also catered many banquets locally over the years. He worked as a carman for the Central Vermont Railway, and later as a foreman for the Public Works Dept. in the City of St. Albans until his retirement in 1985. He was a member of the AFL-CIO during that time. He served on the St. Albans City Council for many years as alderman of Ward 3. He was a communicant of Holy Angels Church. He received an honorary graduate diploma from Bellows Free Academy, St. Albans on June 16, 2002.

His survivors include his children: Daniel Kubas of Tuscon, AZ; Nancy Fiske and her husband, Wayne of Franklin; Bonnie Kubas of St. Albans; John Kubas and companion, Nancy Hayes of Vergennes; and Janet Champagne of St. Albans. Eleven grandchildren: Lori Audet, Carrie Wescott, Heather Smith, Sarah Gonyeau, Jon Fiske, Ashley LaRocque, Michelle and Sherie Dishaw, Ryan, Kyle, and Kasey Kubas. Eighteen great-grandchildren: Alyssa, Alex, Dylan, Caleb, Zachary, Anna, Matthew, Megan, Luc, Andrew, Meredith, Benjamin, Rylee, Gage, Keith, Kristen, Kali, and Kc. He leaves his nieces and nephews: Diane Mahoney and her husband Tom; Tom Kubas and wife, Darlene; Rick Kubas and his wife, Tricia; and Joyce Kubas. He also leaves a sister-in-law, Blanche Kubas of Florida; and two cousins who were 'sister and brother' to him, Helen Nienaltowski of West Rutland, and Bruno Kramarz of Fulton, NY. He leaves several grand nieces and nephews. Four stepchildren: Fred, Jana, Curtis, and Wendy, also survive him. He leaves many friends in the community.

Stan was predeceased by his wife, Marion in 1980, and a daughter, Sally Blondo in 2010; his two brothers, Thomas and Joseph, his sisters-in-law, Joyce Kubas and Lorraine Bartlett, a brother-in-law Harold 'Cherry' Bartlett; and a nephew, Dana Kubas. His second wife, Mary Heald, also predeceased him.
